Citizens Advice Havant (CAH) are looking for new voluntary Trustees¹ to join our current team of six to improve our breadth of skills. We are seeking Trustees with *one or more* of the following: funding expertise (institutional and/or corporate); or social media expertise; or a Havant Borough resident with lived experience; or a Havant Borough resident under the age of 35 years.

Previous Board or Trustee experience is *not* **necessary and we welcome applications from all ages and backgrounds.** We are particularly keen to achieve a more diverse Trustee Board and we welcome applications from all sections of the local Havant Borough community. Our induction process will provide you with the knowledge and support that will allow you to be an effective CAH Trustee.

CAH is the local 'go to' advice organisation offering holistic help to people with difficulties with issues such as benefits, debt, employment and housing. We are here for everyone. We provide free, confidential and independent advice to help people overcome their problems, working to fix the underlying causes. We are a voice for people on the issues that matter to them. We value diversity, champion equality and challenge discrimination.

CAH is a member of the national Citizens Advice charity - which means we have access to fantastic quality assured services, resources and support provided by the national organisation - but as an independent charity, we're responsible for running our own affairs within agreed standards. CAH has been present in Havant since the 1960s. Over the decades the service has adapted and changed but has remained relevant to the needs of the local population, being reflective of the societal and economic environment in which people are living. We operate from spacious refurbished offices located in Havant town centre, along with several satellite outreaches and a variety of phone/online channels. Our highly skilled team of eighteen mainly part-time staff and over sixty volunteers support more than 8,000 clients a year and the local benefit of our support has been assessed at £5.5million per year. Our annual operating costs are around £400K.

We would expect you to:

- be willing to commit to a full three-year term as a Trustee of CAH
- be available to attend: quarterly meetings of our Trustee Board (currently held in-person in late afternoons); meetings of one Board Committee; annual away-day; and our AGM
- be able to commit at least five days per year to fully meet the expectations of being a CAH Trustee. [Note: In their first year, the Trustee induction process will increase this by an additional three days]
- act in the best interests of CAH's clients, staff and volunteers
- work as one member of a team helping to shape the strategic direction of the organisation
- have good independent judgement to lead CAH
- have a commitment to the aims and principles of the Citizens Advice service
- be either a current resident of Havant Borough, or living no more than a one hour commute to the Meridian Centre in Havant.

The role of Trustee is a voluntary one but reasonable expenses can be reimbursed.

Being a Trustee with CAH offers you the opportunity to make a real contribution to our local Havant Borough community and to guide one of the best known and longest established charities through its latest stage of development.

A survey by Getting OnBoard in 2022 revealed that: 96% of trustees say they've learned new skills through their role; 73% say it has boosted their confidence; 84% said that it made them happier; and 86% say it's a good complement to professional and family life. We look forward to you joining us on an exciting and fulfilling journey.

Trustee¹ role profile – all Trustees

Main duties and responsibilities

Each individual member of the CAH Trustee Board has a responsibility to contribute to the effective working of the Board. Their main duties and responsibilities are listed below.

- Maintaining an awareness of CAH's services, operations and business.
- Regularly attending, preparing for and taking a full part in Board meetings and one of the Board Committees ².
- Actively contributing to setting policy and strategic direction, defining goals, setting targets and evaluating performance.
- Actively seeking to further the strategic objectives of CAH, and acting in the best interests of its clients, staff and volunteers.
- Monitoring :
 - whether CAH meets Citizens Advice membership requirements including the performance quality framework and leadership self-assessment process;
 - the financial position and ensuring that CAH operates within its means and objects, and that there are clear lines of accountability for day-to-day financial management; and
 - how well the advice needs of the local Havant Borough community are being met.
- Taking responsibility for their own learning and development.
- Maintaining confidentiality about any sensitive or confidential information received in the course of duties as a Trustee including an understanding of information assurance and data protection.

Personal skills and qualities for all Trustees

Each individual member of the Trustee Board brings skills and qualities to the Board. They add to the collective knowledge and experience by providing the following.

• Commitment and availability to attend Trustee board meetings.

- Effective communication skills and willingness to participate actively in discussion.
- Willingness to gain knowledge of local Havant needs and resources.
- Commitment to the aims, principles and policies of the Citizens Advice service, including those relating to equality, diversity and inclusion (EDI), independence, and research and campaigns.
- Willingness and ability to act in the best interests of CAH's clients, staff and volunteers.
- Ability to understand and accept their responsibilities and liabilities as trustees and employers.
- Numeracy to the extent required to understand accounts with the support of the Treasurer.
- Willingness and ability to learn, and to develop and examine their own attitudes.
- Ability to think creatively and strategically, and exercise good, independent judgement.
- Ability to work effectively as a member of a team.

Time commitment and location expectations

We would expect Trustees to meet the following time commitment and location expectations to be:

- willing to commit to a full three year term as a Trustee of CAH
- available to attend: quarterly meetings of our Trustee Board (currently held in-person in late afternoons); meetings of one Board Committee; annual away-day; and our AGM
- able to commit at least five days per year to fully meet the expectations of being a CAH Trustee. [Note: In Year 1, the Trustee induction process will increase this by an additional three days]
- either a current resident of the Havant Borough, or living no more than a one hour commute to the Meridian Centre in Havant.

Commitment to EDI

³ We use the term equity rather than equality because equity recognises that each person has different circumstances and may need different resources and opportunities to reach an equal outcome. We believe that equity is important to achieving just outcomes.

Additional role profile - Trustee with funding (institutional and/or corporate) expertise

Duties and responsibilities

- Overseeing and supporting the development of a funding strategy for CAH with associated policies, taking account of organisational funding requirements.
- Ensuring CAH develops and maintains relevant funding bid material including community profiles, client journey data, case studies and over-arching socio demographics.
- Ensuring CAH funding activities are agile and focussed on the passion and strengths of the organisation.
- Overseeing robust CAH funding bids within the charitable sector as well as corporates and the public sector, the latter potentially requiring competitive tendering or service level agreements.
- Building CAH relationships with local corporates, including commercial sponsorship.
- Liaising with the CEO and management team on funding matters.

Personal skills and experience

• Ideally we are looking for someone with substantial and proven fundraising experience. However, we would also be interested in an exceptional business development or sales professional looking to use their experience in the charity sector.

Additional role profile - Trustee with social media expertise

Duties and responsibilities

- Overseeing and supporting the development of a social media strategy for CAH with associated policies, taking account of organisational branding requirements.
- Working with the CAH team to create quality, user focused, shareable social media content in different multimedia formats.
- Overseeing CAH social media channels including moderation, paid for and organic content.
- Delivering quality user experience across multiple CAH social channels for social audiences.
- Liaising with the CEO and management team on social media matters.
- Ensuring all social media campaigns are compliant with the CAP code and advertising laws.
- Keeping up to date regarding technology used in social media, and changes within platforms, algorithms and audience.

Personal skills and experience

- Substantial and proven experience of successfully managing, coordinating, and overseeing a suite of social media channels, including moderation, overseeing paid for and organic content calendars and developing social media policies.
- Experience of creating high quality, user focused, shareable social media content in different multimedia formats.
- Experience of delivering quality customer experience across multiple social channels and an understanding of best practice user experience methodologies.
- Comprehensive knowledge of the range of social platforms available and how best to implement a social media based strategy across all of these.
